# I. Executive summary

The European Circular Economy Stakeholder Platform (ECESP), established in 2017 by the European Economic and Social Committee (EESC) and the European Commission, contributes to accelerating the circular economy transition in Europe. ECESP supports businesses, civil society organisations and public authorities accelerating the transition to a circular economy across Europe by fostering dialogue, sharing knowledge and expertise and exchanging good practices with a website, annual conference and regular activities such as thematic workshops or studies.

The ECESP Coordination Group (CG) consists of 24 leading organisations from across the civil society spectrum encompassing European business and trade union associations, environmental groups, national circular economy hubs, waste management, environmental research, and recycling platforms, think tanks, research institutes, and public authorities. Its members come from 13 countries, but drive the conversation on the circular economy across Europe. At its third annual meeting in October 2019, the CG re-elected Ladeja Godina Košir, Founder and President of Circular Change, as Chair for 2020. Through its members, the CG covers a wide range of activities aiming at fostering circular activities and thinking across Europe.

The 2020 edition of the Circular Economy Stakeholder Annual Conference, held on 3-4 November, remained the flagship policy and networking event on the circular economy in Europe. The members of the Coordination Group had an active part in shaping the eight thematic workshops on Day 2 of the conference.

The virtual platform (circulareconomy.europa.eu) has continued to grow into a digital one-stop shop on the circular economy, becoming the reference in Europe. Starting from a few good practices in November 2017, the ECESP website now features over 600+ pioneering circular initiatives, policies and guidebooks. It also regularly publishes upcoming circular economy conferences, workshops or meetings across Europe - a feature actively followed by visitors - and circular economy related news. An ECESP Twitter account (@CEStakeholderEU) has passed the 3000-follower mark since its October 2018 launch, and widens the reach of a specialised community on a daily basis. The Secretariat launched a LinkedIn account in March 2020 which now has over 200 followers.

As the 2017-2020 ECESP mandate of the Coordination is now complete, the new Coordination Group (November 2020-May 2023) will focus on the Platform's contribution to the implementation of the new Circular Economy Action Plan launched by the European Commission in March 2020.

# II. The European Circular Economy Stakeholder Platform

European civil society, businesses and public authorities are committed to a circular economy (CE). To accelerate this transition, in 2017 the European Commission and European Economic and Social Committee (EESC) established the European Circular Economy Stakeholder Platform (ECESP) as a "network of networks" connecting pioneers across sectors, highlighting cross-sector opportunities and challenges. The platform is a hub of knowledge, a place for dialogue and a bridge between existing initiatives. It contributes to anchoring the concept of the circular economy across businesses, government and society at national, regional and local level by making information more easily accessible, and by providing a framework for exchange and discussion.

### 1. Background

The EU is strongly committed to a circular economy and the corresponding more resource-efficient management of all material flows. Back in 2016, with its Circular Economy Action Plan (CEAP), the European Commission kick-started Europe's transition towards circularity; its 54 actions ranging from consumption to production, from waste management to innovation and investment are now all completed or ongoing. Key success factors of the 2016 CEAP include strong stakeholder involvement and interaction, constantly feeding into the policy-making process at all levels, as well as a silo-breaking approach putting together relevant decision-makers across "traditional" departments.

Simultaneously, the European Economic and Social Committee has worked on both the policy level (by adopting opinions on various themes related to the circular economy<sup>1</sup>) as well as the practical level by providing the Platform's Secretariat to manage stakeholder requests and events.

The two institutions jointly launched the European Circular Economy Stakeholder Platform (ECESP) at the March 2017 Circular Economy stakeholder conference, where participants helped shape this Platform to reflect stakeholder expectations and requirements.

To continue with the transition to a circular economy, the Commission adopted a new Circular Economy Action Plan<sup>2</sup> for a cleaner and more competitive Europe in March 2020. This new plan announces a series of actions to change how Europe produces and consumes, putting the focus on preventing waste in the first place. The 35 initiatives announced aim to make sustainable products, services and business models the norm, not the exception. The action plan is at the core of the European Green Deal, leading towards a more resource efficient and clean economy that gives to the planet more than it takes, contributing to EU's climate neutrality ambition.

The Platform will focus on supporting the implementation of the new Circular Economy Action Plan through stakeholder engagement. As we look ahead to the post-COVID-19 recovery, the circular economy will contribute with increased resilience, job creation and an increased autonomy towards a new structure of the economy. The transition towards a circular economy requires the commitment and involvement of civil society, businesses, the knowledge community and public authorities. The Coordination Group will continue delivering on the circular transition and translating policy into action.

#### 2. Structure

The Terms of Reference governing the Platform Aim and Structure rest on three pillars:

- Policy Dialogue: annual two-day conference on the circular economy, with a first day
  focused on policy, and a second on exchanging good practices, in addition to external
  meetings raising awareness on national and European initiatives while gathering local
  evidence and the platform itself providing an online meeting place with dialogue via
  webinars, policy Q&A sessions and expert workshops as well as online discussion forum;
- Coordination: 24-member Coordination Group that brings together existing networks
  pioneering the circular economy in Europe, a <u>Workplan</u> to augment their contribution,

and **Secretariat** provided by the EESC to support the Platform's activities overall and prepare Day 2 of the annual conference, host the virtual platform, and provide business continuity in particular. The ECESP **Steering Group** (composed of the Commission representatives and EESC representatives) provides a coordinated strategy for the ECESP.

• Knowledge, national strategies and good practices: a virtual platform in the form of a website that functions as a one-stop shop for CE knowledge and digital meeting place to exchange contacts, advice and best practices and a brand built on consistent visual identity and a communication strategy. The participants in the Platform will be encouraged to advertise their participation in the Platform both on their websites and in their own events related to the circular economy.

# III. ECESP (2019 - 2020)

From the formal establishment of the European Circular Economy Stakeholder Platform in June 2017 up to the third meeting of its Coordination Group in October 2019, efforts focused on rendering ECESP operational and then developing its profile. 2020 focused on the work of the Leadership Groups a forum of consultation on sectoral matters, and consolidating and finalising the mandate of the first Coordination Group and preparing for the next one.

### 3. Coordination Group

Working together on the <u>Workplan</u> and Leadership Groups the Coordination Group delivered more than 50 initiatives, published on the website (<u>CG Activities</u>).

In 2020, the Leadership Groups were launched with a view to focusing on thematic issues. The following reflections papers were published and served as the basis for the Day 2 workshops of the 2020 annual conference.

### 4. Annual Conference

The 2020 conference, originally scheduled for May after the launch of the new CEAP, was rescheduled to 3-4 November. In line with COVID-19 measures, the event took place completely online for all plenaries and workshops on the rich agenda. More than 1500 participants registered for Day 1 and more than 1200 for Day 2.

#### a. Day 1

Day 1 of the conference, organised by the European Commission in the Charlemagne building on 3 November, featured plenaries and roundtables on the following topics: Consumer information, Waste, Global Alliance on CE and Resource Efficiency, Innovation and Research, and Retailers. It gave a broad overview of current and upcoming challenges for the circular economy in Europe and the successful implementation of the CEAP, with experts and pioneers sharing their experience

and expressing their views on how policy can help amplify the transition. High-level participants included First Vice-President Frans Timmermans, EESC President Christa Schweng, and Commissioner Virginijus Sinkevičius. All plenary sessions and online sessions remain available to view online.

### b. Day 2

On 4 November 2020, the EESC welcomed more than 700 online participants to its online plenaries and workshops. The event left a great impact in social media with over 150,000 impressions on Twitter, bringing the number of followers to the ECESP account to 3500, and with more than 1300 impressions on LinkedIn, adding another 86 followers. On the day of the conference, #CEStakeholderEU was trending at No. 2 in Belgium, and #circular economy was trending at No. 5.

The Coordination Group led the eight participatory workshops on day 2, with more than 40 speakers contributing. The workshops focused on the circular economy in the following areas: Textiles, Procurement, Construction, Food waste, Consumers, Cities and Regions, Roadmaps, and Economic Incentives. As in the previous edition, a pre-event factsheet and post-event report are prepared for each workshop and remain available online.

An online Networking Village allowed stakeholders to connect with ongoing <u>projects</u>, discover <u>good practice examples</u> linked to the workshops on Day 2, and discover the newly-launched <u>EU</u> Circular Talks to continue circular debates on a specific topic.

The conference was followed by three side events: <u>R&I Funding opportunities for the circular economy</u> (organised by DG RTD), <u>Presenting the OECD synthesis report on The Circular Economy in Cities and Regions</u> (OECD), and the <u>Circular Economy under the German EU Presidency</u> (FEAD).

### 5. Website

The ECESP virtual platform was launched in November 2017, with a website hosted by the EESC and managed by the ECESP Secretariat. In December 2019, the Commission engaged the services of an external contractor to help increase the number of submissions on the Platform and to revive the online dialogue, both via the discussion forum and thematic webinars through #EUCircularTalks concept.


In October 2020, the Platform re-launched the homepage with a fresh new look, designed to improve usability, and to introduce two new features on the website. A deeper re-vamping of the website is planned for 2021-2022.

#### c. Visitors

Since its launch in November 2017, the ECESP website has received over 270,000 visits and over 610,000 unique page views. For the period October 2019-September 2020, the website had over 85,000 visits and over 193,000 unique page views. The graph below shows that interest in the virtual platform has steadily increased since its creation.

Although the number of visits on the platform fluctuates, many indicators, including social media and the number of submissions, show an increasing interest in the Platform's activities. The graph below depicts the fluctuations and regain of interest, in terms of visitors, after low periods.

It is important to note that, in the previous years, the number of unique visitors tended to increase around the annual conference. The conference, traditionally held in the Spring, adapted to a different format in November 2020, due to the health crisis.



The same crisis explains the relatively low figures for 2020. However, the November 2020 conference edition going digital is expected to have a positive effect on web traffic. The preliminary statistics for


early November already indicate over 4,000 unique visitors, compared to 5,200 unique visitors for the whole month October.

Further analysis by content type shows that, after the homepage, Good Practices, Knowledge and Strategies remained the most popular sections of the ECESP website:


With content from 33 countries (see figure below), the ECESP website has steadily increased the number of good practices, reports and strategies made available to Europe's CE community in the year up to October 2020, while the number of commitments on this website has stagnated.




■ Knowledge items


# ECESP online content - 9Rs

At the end of 2019, the European Commission engaged Technopolis, an external contractor, to help generate content for the website, and to revive the forum. From the Platform's infancy, the forum was considered as an important feature. It was envisaged as an online space where stakeholders and members of the circular economy could come together and exchange.

However, despite the potential of the idea, the forum has had a very slow uptake.

To revive the section, Technopolis launched an

online survey followed by a series of interviews with members of the Coordination Group to understand better the needs of the community for this type of functionality. In its report, barriers were identified linked to the concept of the forum, and solutions were proposed to revive this section of the online platform.

Among the solutions, the #EUCircularTalks were proposed: a concept to create a space where members of the circular economy community could participate in thematic workshops and discuss the outcomes online. The first of the series on Education, Skills and Training took place on 9 October followed by a second on Packaging on 19 October.

The official launch of the concept by the Commissioner for Environment, Oceans and Fisheries, Virginijus Sinkevičius, took place on the first day of the November 2020 annual conference. In runup to this event, an increase was observed in the number of new forum users, but no significant improvement on the discussions. The Secretariat, together with Technopolis, plan further communication campaigns on social media to foster the debate on the forum.

#### e. Developments

Following the results of the survey by Technopolis, the ECESP deployed a light revamping of the homepage. This exercise addressed the immediate remarks from the survey and introduced two new sections: circular economy education and financing.

The next objective is to revamp the entire website to take it to the next level.


#### f. Social media

ECESP is present on two social media platforms: <u>Twitter</u> and <u>LinkedIn</u>.

The Twitter account was launched in October 2018 and as of November 2020 has more than 3,500 followers. The account registered an increase of over 260% in the number of followers between October 2019 and October 2020, growing from 1,241 to 3,507 followers.

The ECESP LinkedIn page was launched in March 2020. The objective set for 2020 was of 250 followers by December of the same year. The Platform has seen steady growth in its online community and exceeded the set objective. By November 2020, the LinkedIn account had more than 700 followers.





# IV. Next steps: ECESP in 2020 and beyond

The ECESP is an established feature in the European circular economy community, and the EU has delivered a fresh impetus through its new Circular Economy Action Plan launched in March 2020. The COVID crisis has brought its own challenges to the transition to a Circular Economy, but has also served to highlight the importance of a resilient and sustainable economy that respects the planet's boundaries. With the circular economy remaining very high on the overall European policy agenda, we need to ensure continued stakeholder engagement on the circular economy.

At the end of one successful mandate and the beginning of another, it will be ever more important to continue building on the Platform's recognition and momentum. The role of the incoming Coordination Group will be to ensure these objectives are met.
