## **Key Questions**

- Where have European governments adopted circular economy strategies to date and where are such roadmaps currently being developed?
- What common threads form the hallmarks of a circular economy strategy in Europe? Can a synthesis of these overlaps provide a blueprint for governments and civil society drafting a strategy?
- To what extent have the strategies in place been implemented? What are the preconditions for successful and consistent implementation of circular policy commitments? What role do civil and social organisations play in delivering these alongside businesses and governments?
- Are circular economy strategies coherent with overarching social and economic strategies? How can they support the achievement of the Sustainable Development Goals, especially 12 (sustainable production and consumption) and 17 (partnerships for the goals)?

# Setting the scene

While the circular economy (CE) was unheard of in European policy a mere decade ago, the term seems to have become ubiquitous by 2019. In parallel to the European Commission implementing its "Closing the loop" action plan since December 2015, a burgeoning set of CE policies has been adopted by governments across Europe. These range from national action plans (*France, Slovenia*) that contribute to European targets for climate change mitigation and waste management, to regional initiatives (*Central Macedonia, Päijät-Häme*) directly linked to European structural and investment funds, and local strategies (*Maribor, Brussels*) catalysing a systemic rethink of the relationship municipalities have with the resources that flow in and out of their territories.







Despite CE becoming a mainstay of industrial strategy over the past few years, there has been no comprehensive mapping of circular policies across Europe to date. As more and more civil and social organisations are teaming up with businesses and national, regional and local governments across Europe to draft such pathways to sustainable resource use, there is a wealth of potential expertise and knowledge that could support these actors taking their first steps towards a circular economy.

The *European Economic and Social Committee*, which provides the Secretariat of the *European Circular Economy Stakeholder Platform*, has commissioned policy research on circular economy strategies in Europe to overcome this evidence gap and provide circular newcomers with actionable guidelines on drafting CE strategies. Interim findings from this research will be presented at this workshop alongside presentations of national initiatives in Italy, Romania and France, while contributions from the floor can help shape the *adaptable model strategy* being developed.

- Spatial Foresight will publish its *final report on Circular economy strategies and roadmaps in Europe* by May 2019
- As the coordinator of *ICESP* (*Italian Circular Economy Stakeholder Platform*), ENEA will continue supporting Italy's public administration and private enterprises with implementing circular strategies. In partnership with the Ministries of Environment and Economic Development, *ENEA is designing an indicator set to monitor the circular economy in Italy*.
- **IRCEM** is campaigning for Romania's government to adopt a circular economy strategy. To ensure citizen and civil society engagement provides buy-in for such a strategy, IRCEM will be hosting 7 regional consultations in collaboration with Romania's Ministry of Environment and host a **final conference on June 11th in Bucharest** to present the **Roadmap for developing a strategy on the circular economy in Romania**.
- The **4th Circular Change Conference**, to be held 16-17 May in Maribor, will tackle the 4 priority sectors of the **Slovenian roadmap towards the circular economy** and focus on business cases delivering this roadmap.
